MEETING CALL:

The Regular Village Board Meeting with the President and Board of Trustees of the Village of Kingston was called to order at 7:00 pm by President John Munro, Monday, December 7, 2009, in the Village Board Room, at the Kingston Municipal Building, 101 E. Railroad St., Kingston, DeKalb County, Illinois.

Attorney Attorney Buick reported that he has a memorandum for the sewer committee.

Attorney Buick informed the board, as previously discussed, the retainer fee will be raised from \$650.00 to \$750.00 and the hourly rate would go from \$135.00 to \$145.00 after the first of the year. The retainer fee would include sending out letters to individuals who have not paid their ordinance violation ticket.
